**Millennium Bank, Inc. (in liquidation) ("the Company")**


Further to an order of the Eastern Caribbean Supreme Court in the High Court of Justice, Saint Vincent and the Grenadines dated 3 May 2010, Millennium Bank Inc. was ordered to be wound up. Charles Thresh of KPMG Advisory Limited and Kris Beighton of KPMG in the Cayman Islands were duly appointed as Joint Liquidators ("JLs") of Millennium Bank Inc (the "Bank") on 3 May 2010.

A first and possibly final dividend is intended to be declared in the above matter. Should you have any claim against the Company, you must complete and return the enclosed proof of debt and supply details of your claim together with supporting documentation no later than 15 October 2010. 15 October 2010 is the deadline for submission of proofs of debt per the notice that is enclosed and as it appeared or will appear in the Searchlight newspaper on 13 and 20 August 2010 and in the Official Gazette.

Creditors who have already returned a sworn proof of debt do not need to submit a further proof. However should you wish to vary your claim you should submit a revised claim which will supersede your earlier claim, prior to the bar date.
